## **CALIFORNIA RESIDENCY DOCUMENTATION - CHECKLIST:**

Veterans and Members of the Military may establish residency by submitting the Residency Affidavit Questionnaire and the following required documentation:

- Military Photo ID (copy is not necessary, please show photo ID to A/R staff)
- Copy of Military Orders designating California station (documentation must be provided)
- DD0214 (Member 4 copy)

Veterans and Members of the Military who **DO NOT HAVE ABOVE DOCUMENTATION** must provide two forms of proof from the lists below, **at least one of which must be a primary document.** 

The burden of proof is on the student to clearly demonstrate both physical presence in California and intent to establish California residence. You are required to present evidence in accordance with Education Code Sections 68040 et.seq. The documents presented must be valid, readable, *DATED AT LEAST ONE YEAR AND ONE DAY BEFORE THE RESIDENCY DETERMINATION DATE FOR THE SEMESTER IN WHICH YOU ARE PLANNING TO ATTEND, AND BE PROPERLY IDENTIFIED WITH RESPECT TO STUDENT NAME AND ADDRESS.*

- □ Utility bills (electricity, phone, or water)
- □ Official high school transcripts/High School diploma (AB-540) (not college)
- Affidavit from landlord stating length of residence
- □ College Transcripts
