Under the Education Code, the general rule is that a student must have been a legal California resident for at least one year immediately preceding the semester residence determination date in order to qualify as a “resident student” for admission and tuition purposes. The burden is on the student to demonstrate clearly both physical presence in the state of California and intent to establish permanent California residence. You must provide at least two pieces of documentation that prove you resided in California one year and one day prior to the start of the semester and that you intend to make California your permanent residence.
