If home state of record and address after separation is California residency will be established in the state of California. Section 1005 of the Isakson and Roe Act removes the requirement for covered individuals to enroll in a course at a public institution of higher learning within three years of discharge in order to benefit from in-state tuition and fees.

Isakson & Roe replaced Veterans Access Choice and Accountably Act (VACA), which limited Veterans to enroll in an institution of higher learning within three years of discharge.

CALIFORNIA RESIDENCY DOCUMENTATION - CHECKLIST:

Veterans and Members of the Military may establish residency by submitting the Residency Affidavit Questionnaire and the following required documentation:

- Military Photo ID (copy is not necessary, please show photo ID to A/R staff) AND
- Copy of Military Orders designating California station (*documentation must be provided*)
 OR
- DD214 (*Member 4 copy*)

Veterans and Members of the Military who **DO NOT HAVE ABOVE DOCUMENTATION** must provide two forms of proof from the lists below, **at least one of which must be a primary document.**

PRIMARY DOCUMENTS:

- California Income Tax
- □ CA driver's license or ID card
- □ Carrying on of business or employment in CA
- □ Vehicle registration in CA
- □ Recipient of CA state services
- □ Current W-2 Form showing address
- □ LES showing California
- □ Military Change of Home of Record Verification

SECONDARY DOCUMENTS:

- □ Ownership of residential property as primary residence
- $\hfill\square$ Continuous occupancy of rented or leased property in CA
- □ Maintaining active checking/savings accounts in CA banks
- □ Utility bills (electricity, phone, or water)
- □ Official high school transcripts/High School diploma (AB-540) (not college)
- □ Affidavit from landlord stating length of residence
- □ College Transcripts
