	<p><b>The District is currently in negotiations with BCFA. Between January 15, 2020, and May 13, 2020, the parties met and conferred approximately seven (7) times regarding joint priorities and issues to address in negotiations. Between May 27, 2020, and December 2, 2021, the parties met to negotiate terms of a successor agreement on thirty (30) separate occasions, culminating in tentative agreements on nine (9) separate contract articles. No tentative agreement has been reached on Article 7 ("Hours, Terms, and Conditions of Employment"), Article 8 ("Salary") Article 9 ("Health and Welfare Benefits"), and Article 12 – Evaluations and evaluation forms.</b></p> <p><b>The parties are currently at impasse mediation and have met on three occasions with the mediator. Significant progress has been made in all areas and it is anticipated that an agreement will be reached prior to factfinding. It is not anticipated that there will be a significant impact, as the current economic proposals on the table are within or below the State-funded COLA.</b></p>
