5.1 Director's Updates

Conference & Events Updates:

- GED National Conference: September 16 recognized as National GED Day, promoting recognition ceremonies and outreach. Consortium launching a community-wide campaign this fall.
- U.S. Citizenship Celebration: Planned recognition for new U.S. citizens (tentatively at Barstow Adult School).
- Baker Valley Outreach: Continued partnership with Barstow College departments at Baker Valley open house.
- Silver Valley Outreach: New Winter Fest Adult Education event planned.
- Consortium Graduation: To include both Barstow and Baker Valley students; held at the BCC Performing Arts Center.

5.3 Member Program Update: Barstow Adult School – **BUSD**

- Enrollment at capacity: 220 students (60 returning, majority new).
- Staffing shortages: two teachers; awaiting August 26 board approval to hire.
- CASAS testing in progress; enrollment capped at 100 for testing capacity.
- GED and ESL referrals are being made to BCC.
- Pearson VUE testing is ongoing, scheduled bi-monthly.
- 5.4 Member Program Update: Barstow Community College BCC

- E. Bagg shared about the new Vice President, Mike Wagner. Launching a Title 5—funded MESA (Mathematics, Engineering, and Science Achievement) program to support STEM students; BCC board approval secured, and funding expected from the Chancellor's office

Community Engagement & Economic Growth:

- E. Bagg shared BCC is hosting the City of Barstow Town Hall meeting on September 4 at 6:00 p.m. where the City of Barstow will provide updates regarding regional development with BNSF and the upcoming city's general plan. They will be addressing the anticipation of workforce training needs tied to regional projects, including the Castle Mountain Gold Mine expansion near Baker.

Medical Coding Program:

L. Alvarado shared there was a strong response to the Medical Billing & Coding training enrollment with 39 funded slots filled and 108 students on the waitlist within three days.
 Program is 100% virtual, positioning it as a model for other workforce programs accessible to students facing barriers such as transportation, childcare, and health issues.
 This demonstrates there is a need for stronger outreach to adult education programs identified to better connect students to opportunities.

Workforce Readiness & Career Services:

- L. Alvarado shared the plan to expand the **Career Resource Fair** with the support of a subcommittee; event to include on-the-spot job interviews, record expungement services with a commissioner/judge, access to the career closet, and cosmetology services (haircuts/manicures) for participants prior to interviews. Multi-day event will emphasize "second chance" employment, particularly for justice-involved students.
- Career workshops will begin in September and continue monthly, by our Career Readiness Coordinator, Melissa Church; this service is open to consortium students with a BCC ID.

GED Preparation Workshops:

- GED preparation workshops transitioned from Aztec to Essential Education software. GED program has expanded through a partnership with Community Solutions Incorporated MAP program, serving justice-involved students. The weekly workshops began on July 7, with a cohort of 14 students enrolled.
- ESL classes offered at both the Barstow and Fort Irwin campuses. Basic Skills continues to be offered at Ft. Irwin in the BSEP program. Students in these two areas will no longer be CASAS or TABE tested since they receive short-term certificates reported through MIS.

Support Services & Resources:

- As of August 1, 2025, BCC AE now has a permanent part-time department secretary, Katherine Cortez. She will oversee the Consortium Barstow Area Resource Guide project and the monthly parenting workshops (FKCE).
- Recent feature in Pulse Publication highlighted BCC as the "North Star" for the region and it included a complimentary BACAE consortium advertisement.

5.5 Member Program Update: Baker Valley USD

- No representative present.

5.6 Member Program Update: Silver Valley USD


- CASAS testing has begun.
- Officially designated as a HiSet testing center; testing offered every Saturday and Sunday from 7:30 a.m.–1:30 p.m.

- Enrollment is currently at 100 students, with capacity to accept additional students, including overflow referrals from BAS.
- Programs operate primarily online, but students can meet with teachers via Zoom for support.
- Recently transitioned to a new curriculum software to support instruction and student success.
- Expanded capacity for multiple certifications available on-site.

- Payments for July/August are pending until allocations are finalized.
