

**MEMORANDUM OF UNDERSTANDING
BETWEEN THE BARSTOW COMMUNITY COLLEGE DISTRICT
AND THE BARSTOW COLLEGE FACULTY ASSOCIATION
COMMON COURSE NUMBERING COMPENSATION**

This Memorandum of Understanding ("MOU") is entered into by and between the Barstow Community College District (hereinafter referred to as "District") and the Barstow College Faculty Association, an affiliate of CTA/NEA (hereinafter referred to as "BCFA") and is expressly made pursuant to the Educational Employment Relation Act and the current collective Bargaining Agreement (CBA).

Purpose

The purpose of this MOU is to establish compensation and recognition for faculty work required under Assembly Bill (AB) 1111, Common Course Numbering (CCN), as directed by the California Community Colleges Chancellor's Office.

Background

AB 1111 requires all California community colleges to adopt and implement a common course numbering system to align curriculum across the state. To comply with this legislation, faculty are responsible for reviewing, revising, and resubmitting courses through the District's curriculum processes to ensure alignment with the state-mandated system.

Agreement

1. Faculty assigned this work by Academic Senate and overseen by a District Dean of Instruction shall be paid \$500 per course completed in compliance with the requirements of AB 1111 and Curriculum Committee processes.
2. The District and the Association agree that the following language will be added to Appendix D:
"CCN Curriculum Work, \$500 per course" under the STIPENDS — Full-time Faculty; and
"CCN Curriculum Work, \$500 per course" under the STIPENDS — Part-time Faculty.
3. This agreement shall be applied retroactively to the beginning of the project, Fall 2024, and will remain in effect until the completion of the work.

Duration

This MOU shall become effective upon signature by both parties and shall remain in effect until the completion of the AB 1111 implementation project, unless modified by mutual agreement.
