- 5. Consortium Director's Report
 - Director's Update E. Rivera is continuing to market the consortium through the local free 5.1 newspaper "Tidbits" on a monthly basis until the end of the school year. BAS was visited by E. Rivera and she was able to meet the new staff and teachers. She received feedback of what the barriers the adult ed. students face. Open House event can be used to promote more student interest in our program.

- 5.2 TTA Update: Meeting schedule with Ryan De La Vega this Thursday to go over the consortiums districts DIR and getting feedback on how and what to improve on.
- 5.3 ^aCAEP Updates: CAEP Webinar: Three-Year Plan in NOVA Dec. 8, 2021
- 5.6 Member Program Update: BAS M.Colleoc, reports 149 enrolled students 107 in high school diploma and 47 in the G.ED. 4 students were CASAS tested the day before, and we still promoting CASAS testing be administered before entering their high school or G.ED training. Mondays are for CASAS testing, all of BAS staff is G.ED certified.
- 5.7 Member Program Update: BCC E. Bagg reports we have CTE noncredit class starting with the SBC probation, BCC is also working on developing a noncredit class for the Entrepreneurial center. E.Rivera reports, our transitional adult ed. counselors have been very busy contacting and working with our Adult Ed. students and are available to all of the consortium students to use. We will be tracking all the students they are working with to report on. The CTE noncredit classes will begin February 18 and we will also have a CTE noncredit cohort with the probation department starting in March. BCC has now purchased equipment for the Entrepreneurial center and are now planning to meet with students when the campus opens.
- 5.8 Member Program Update: BVUSD
- 5.9 Member Program Update: SVUSD B.Scott, reports that they have received full WASC accreditation for the first time in the history of the district. Ed2Go enrollment is very popular in the community, Silver Valley is covering some of the cost for the Adult Ed students. They are also offering career training programs that are longer than their 6-week program, like pharmaceutical tech. They are currently working with the Army and they are covering the tuition for the longer ed2go trainings. Hybrid is still offered for the Adult ed. in basic skills and ESL, they have increased their number of testing because they moved their testing cites to be opened on Saturday and Sunday.
- 5.10 BCC Fiscal Agent Report E.Rivera reports on behalf of Terri Walker that, all invoices for the month of March have been processed through payment. There is still one outstanding warrant for Baker Valley and that is from the month of November. Barstow Unified has two outstanding warrant and it is for the month of January and February.

6. Discussion Items DR. Helga Wild

6.1 Update: 3-Year Plan 2022-2025

Dr. Helga Wild was able to meet with various consortium members to receive feedback on what the district needs are for the community. Dr. Wild reports that with COVID-19 students have not been wanting to return to campus, and therefore we have not been able to track our student numbers. The fragile groups we work with are not succeeding during this online/ hybrid training in Adult ed. ESL program and students is shown to have been growing in the past few years in the consortiums and how can it continue to develop. A new group of people have emerged in the Barstow community from different parts of the state who have moved here because of housing affordability, an idea of how to reach out and bringing them in and develop local connections. Emotional baggage is something that holds a lot of people back from pursuing their education and also child care is a barrier. The general idea she received was that students want to get into a career field that will guarantee profit quickly vs perusing their passion/dream career where they feel they might not be as successful. However, it is much more appealing to them if they are able to go into a career field in the arts or even entrepreneurship. Dr. Helga, believes that so far, the way the consortium is working is the correct path towards the three-year plan.


